Res and a second	If you turn to the court, the dispute between you and "Global Credit" UCO CJSC is solved by the court. You may turn to the court in any phase of complaint examination. The court award can't be reexamined by the Financial System Mediator.
	<ul> <li>In case if you turn to the Financial System Mediator the disputes between you and "Global Credit" UCO CJSC will be solved by the Mediator in the manner prescribed by RA Law on "The Financial System Mediator".</li> <li>Services rendered by the Financial System Mediator are FREE OF CHARGE.</li> <li>If you have a complaint, first of all you should turn to "Global Credit" UCO CJSC. "Global Credit" UCO CJSC has to answer you within 10 working days. In 10 days after receiving the answer or without it you may turn to the Financial System Mediator.</li> <li>The Financial System Mediator cannot examine your complaint, if:</li> </ul>
Financial System Mediator	<ol> <li>The 10 working days have not been expired since presenting the complaint to "Global Credit" UCO CJSC.</li> <li>You do not demand money compensation or property compensation, or the amount of the compensation exceeds 10 000 000 AMD (or equal currency).</li> <li>Six months have passed since receiving the answer from "Global Credit" UCO CJSC.</li> <li>The objected action or inaction took place before 2 August 2008.</li> </ol>

We warn you that the Financial System Mediator cannot examine your complaint if it is examined in the court (or in arbitrary tribunal) or if there is a court award (or arbitrary tribunal award) on it.
